



## President Trump: The Closest Person To Being The Antichrist

President Elect Donald Trump is the person closest to being the Antichrist than any other person throughout history. I know this statement will not fair well with many who look at Trump as sent by God, and I cannot disagree with them; but for what purpose has he been sent? To revive America and her Christian principles or to further establish the path for the final global leader we call the Antichrist? As with all American Presidents, Trump has been chosen by the Devil and permitted by God to lead the world to embrace the arrival of the Antichrist.[1] Someone may bring up the fact that Trump supports many Christian values, receiving the support of many Christians. Yet, we must not forget that so did Hitler and so will the Antichrist before turning against them.

Here are ten characteristics of the Antichrist which Trump has mastered:

1. Skilled orator (Daniel 7:20)
2. Arrogant (Daniel 7:20)
3. Access to great Military power (Daniel 8:24; 11:38)
4. Promotes prosperity, economic growth (Daniel 8:25a)
5. Self-magnifying (Daniel 8:25b)
6. Vile and despicable (Daniel 11:21a)
7. Wins people with flattery (Daniel 11:21b)
8. Willful (Daniel 11:36a)
9. Exalts himself above God (Daniel 11:36b)
10. Uses technology to mandate a cashless economy (Revelation 13:14-17)  
*Trump intends to use technology to advance the cashless economy.*

### TRUMP ALSO IS MOST LIKE THE ANTICHRIST IN HIS POLITICAL AMBITIONS

Considering that the Antichrist will confirm a seven year treaty between Israel and her enemies (Daniel 9:27), mandate a global cashless economic system (Revelation 13:15-17), and govern over the realignment of all nations under ten global regions (Daniel 2:41-43; 7:7-8), we find that Trump also has these same ambitions.

### IN HIS FIRST TERM

Trump focused on **peace between Israel and her neighbors** in doing what no other president dared to do before him. He officially recognized Jerusalem as Israel's capital on December 6, 2017 and made this clear when he

moved the U.S. Embassy from Tel Aviv to Jerusalem on May 14, 2018. The significance of this date is that it coincides with President Harry S. Truman's recognition of Israel as an independent nation on May 14, 1948, exactly seventy years to the date, one generation apart. This is significant because before the Antichrist arrives, Jerusalem must be the official capital of Israel. Due to Trump's action, Jerusalem is in position for the arrival of the Antichrist.

Another significant event Trump achieved in his first term with Israel and her enemies was the signing of the **Abraham Accords** on September 15, 2020. Through this agreement many of Israel's enemies recognized Israel's sovereignty, opening the door toward full diplomatic relations which are necessary when the Antichrist arrives to, not draft a new treaty, but to confirm one that is already in place.

These two achievements are as significant as Israel regaining her statehood in 1948 and repossessing Jerusalem in 1967, confirming that we are not only in the last days, but the final generation that puts into place the final pieces necessary for the Antichrist to rule over the world's first truly global government. Again, it becomes clear that Trump has been chosen to lead the world to soon welcome the Antichrist with open arms.

### ***IN HIS SECOND TERM***

Trump will continue to lay strong foundations in the area of the digital transformation outlined by the United Nations in their Agenda 2030.

On his "X" account he announced on August 29, 2024 his goal to make the United States the **"CRYPTO CAPITAL OF THE PLANET"**. He confirmed this goal in subsequent statements to create a cryptocurrency reserve.

His crypto goals are the extension of the foundation laid by COVID for cashless transactions as businesses began to focus more on kiosks, automation, credit cards, and other methods of cashless transactions in order to reduce the risk to health and safety. Following up on the COVID cashless direction, President Biden, on March 9, 2022, signed an Executive Order directing the government to explore the risks and benefits of cryptocurrency. This laid the foundation for President Trump's emphasis in his second term to make the United States the "crypto capital of the planet," his commitment to building a crypto reserve, and his appointment of crypto, digital, and artificial intelligence experts.

The significance of this decision is that not only does it fall in line with the United Nations Agenda 2030 for a global cashless economy but also lays the foundation for the global cashless economic system the Antichrist will mandate. With the U.S. taking this step will encourage other countries, if not most, to follow his lead. The United Nations goal is to have it all in place no later than 2030. Trump's whirlwind, turbo charged personality will ensure these goals are met.

**ARTIFICIAL INTELLIGENCE (AI)** will continue to be a focus as it walks hand-in-hand with the cashless economy. In his first term, Trump signed Executive Order 13859 on February 14, 2019, to maintain America's leadership in AI, by increasing AI research. As with cashless currency, AI's development is crucial to the Antichrist's ability to have an image capable of adding life, a spirit, to an image made of wires, chips, electricity, and silicone.

**TEN REGIONAL GROUPINGS.** Take a look at this [ten-region grouping map](#) published by the United Nations and note the North American Region. The nations in this region are the United States, Canada, and Greenland. With Trump's current desire to make Canada and Greenland part of the United States certainly falls in line with the United Nations goals. As with his focus on digital currency, Trump is certainly putting his hands to the plow when it comes to executing the will of globalists. It makes you wonder how much of a globalist he really is. The real consideration is that the Antichrist's goal is to have all nations realigned under ten global regions, which fits perfectly with the United Nations Regional Groupings. Again, there is no doubt in this author's mind that Trump has been given a second term to finalize the cashless economy and move the nations toward this realignment in the name of economic stability. Trump is in authority to pave the way for the world leader we call the Antichrist.

## PEACE WITH ISRAEL

As we saw with his first term, **PEACE WITH ISRAEL** was a major focus. I also expect it to be his focus in his second term. I expect there to be an adaptation of one of the treaties to include a provision for the rebuilding of the temple. This would be a major undertaking for her enemies to give up the Temple Mount. Though I don't expect an agreement including the rebuilding of the temple to be achieved until the Antichrist appears, I can see a treaty being adjusted to include, or at the least to hear of talk of including it between now and 2030. An agreement with this provision would not be effective until the Antichrist signs the treaty. The Antichrist, as an enemy of Israel, has the motivation for such a provision since he wants to take his place in the temple as God (2 Thessalonians 2:4). This provision will also be motivation for Israel since the temple at Jerusalem is crucial to their identity, culture, and worship.

## A COUPLE OF THINGS

A couple of other events which parallels the coming Antichrist is Trump's intent to end **DAYLIGHT SAVINGS TIME**, which parallels the Antichrists changing of times and seasons (Daniel 7:25). And then there is **THE HEAD WOUND** which could have been fatal, which saw him rise to his feet as one who had risen from the dead (Revelation 13:3). Another aspect identifying Trump with the Antichrist is his threats and use of policy and **MILITARY MIGHT** to create peace and economic stability, paralleling the Antichrist's prosperity through warfare (Daniel 8:25)

## I DID NOT SAY

To be clear, I am not saying that Trump is the Antichrist, only that he is a type that is most like the Antichrist than any world leader we've had to date. He is such a pattern of the Antichrist that as we look at Trump, we observe the Antichrist. With the Antichrist's character and political ambitions, he is able to move the nations to complete the infrastructures necessary for the Antichrist's arrival, as he has the mind of the Antichrist like none other.
